You said your priority was:	Anti social behaviour in Gas Works, Central, Etnam St, Spar Car parks. Vehicles congregating within the car parks, causing anti social behaviour and leaving litter.

We have undertaken:	<ul style="list-style-type: none"><li>• High visibility patrols conducted by the Safer Neighbourhood Team.</li><li>• House to House surveys conducted by the Safer Neighbourhood Team in the area.</li></ul> <a href="#">Update 04/08/2016</a> SNT continue to actively patrol the area and will deal robustly with Offenders causing Anti Social Behaviour and Criminal Damage.

The West Mercia Police area and especially North Herefordshire remains low crime. That said a number of incidents have occurred during the month and I would ask you to have a look at these to see if you could help with any information which may assist us in bringing the offenders to justice. Let me know if you need any crime prevention advice.

*Criminal damage* – Damage was caused to 2 fence panels at a property in Buckfield Road. This happened sometime overnight of 10<sup>th</sup> / 11<sup>th</sup> July 2016. *Incident 136S 110716.*

*Criminal damage* – A window was damaged at a building near to the Priory. This happened sometime overnight of 12<sup>th</sup> / 13<sup>th</sup> July 2016. *Incident 133S 130716.*

*Theft* – A large terracotta plant pot was stolen from outside a property in Godiva Road. This happened sometime between 11<sup>th</sup> / 15<sup>th</sup> July 2016. *Incident 389S 150716.*

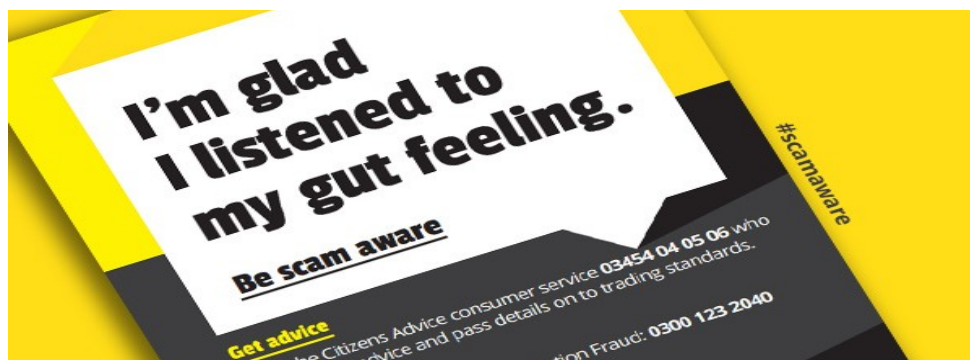

**Action Fraud is supporting Scams Awareness Month - a national campaign launched by Citizens Advice to help people avoid falling prey to scams.** The campaign urges people to take three steps to avoid being ripped off - get advice, **report them** and tell others about it. Research conducted by Citizens Advice finds fraudsters are using a variety of tactics to get people to part with their cash, with people losing an average of £2,500.

Scam methods include **Vishing** whereby scammers cold-call people in a bid to get their bank details, and offers of fake services, such as telling people their computer has a virus which they can fix remotely. Investment scams carried the highest price tag, with people investing in fake diamonds or bogus stocks and shares losing of on average £20,000 each.

### **Spotting scams, a fraudster may:**

- Contact you out of the blue.
- Make promises that sound too good to be true - if something sounds too good to be true it probably is.
- Ask you to pay for something up-front - for example, they'll ask you to pay a fee before you can claim a prize.
- Ask you to make a quick decision by saying things like 'if you don't act now you'll miss out'. This puts you under pressure and doesn't give you time to think.
- Be over-familiar and over-friendly with you.
- Tell you an offer has to be kept secret.
- Ask for your bank account details. Never give your bank details to people you don't know, especially people you meet online.
- Give a mobile number or PO Box number as the contact for their company- these are easy to close and difficult to trace. It may be a sign that the company doesn't exist or isn't legitimate. Check out the company's details with Companies House or look on the internet for more details about them.

If you think something might be a scam, don't reply - then throw it away, delete it or hang up and get further advice. Please note that Action Fraud is not responsible for the content of external websites.
