MINUTES OF THE ANNUAL MEETING OF LUSTON GROUP PARISH COUNCIL HELD AT 7.30PM ON MONDAY 14 MAY 2018 AT CAWLEY HALL, EYE, LUSTON

1. Election of Chairman

Nomination received for Cllr. I Stevens. **DECISION:** It was declared that Cllr. I Stevens is duly elected as Chairman. Cllr. Stevens signed the Chairman's acceptance of office.

3. Declarations of Interest.

4. Election of Vice Chairman

Nomination received for Cllr. J Coates. **DECISION:** It was declared that Cllr. J Coates is duly elected as Vice Chairman.

7. Matters raised by local residents.

A member of the public asked when the pavement by the Methodist Chapel, Luston, which floods at times of heavy rainfall, will be repaired. It was confirmed the defect has been reported to Balfour Beatty, the agent for the highways authority. A member of the public asked whether Welcome Packs were still provided for new residents, and this was confirmed.

There was concern expressed that the new bridge put in place on Eye Lane will cause problems for long vehicles, and that there should be road signs either side warning of the risk of grounding. Ward Cllr. Bowen said Balfour Beatty is to look at the experience of vehicles using the bridge for the time being.

8. Ward Councillor S Bowen's Brief Report (for information only)

Ward Cllr. Bowen provided a written report which was noted. Potholes will be looked at with the locality steward. The ongoing problems with the pavement by the chapel and drain by Holy Well will be raised again with Balfour Beatty. At the request of the group parish council, Cllr. Bowen said he will also ask Balfour Beatty about the work required on the trees by the entrance to the Willows and adjacent to Eyton Lane, which have been reported.

- **9.1** 181090 Eye Manor, Eye, HR6 0DT. Listed building consent. Proposed upgrades to walls and floors in the cellar of Eye Manor. **COMMENT:** Luston Group Parish Council supports the application for listed building consent.
- **9.2** 181108 Berrington Hall, Berrington, HR6 0DW. Listed building consent. Proposed refurbishment of the existing Male WC, moving the ladies WC's to a new location adjacent to the male WC and creating a combined changing place, disabled WC and baby change area within the existing female WC. **COMMENT:** Luston Group Parish Council supports the application for listed building consent.
- **9.3** 181481 –Townsend House, Townsend Park, Luston, HR6 0DZ. Proposed removal of dead tree (Prunus) because it is in a dangerous condition. **DECISION:** As the tree has already been removed it was agreed not to comment.
- 9.4 181608 19 Townsend Park, Luston, HR6 0DZ. Proposed works to 2 x trees. Both to be felled to the height of the existing hedge line to maintain a barrier into the adjacent field, however if the trees are felled and they do not leave a gap in the hedge line then the trees will be taken down to floor level and replaced with a natural hedge to match existing hedgerow. **COMMENT:** Luston Group Parish Council supports the application for tree works.
- **9.5** Update on planning decisions/ enforcement by Herefordshire Council. Works to trees within the conservation area allowed for 180639 Walnut Tree Cottage.

APP/W1850/W/17/3190468 Appeal re: 172686 Land at The Nest has been dismissed by the Planning Inspectorate. The group parish council expressed concern that the reasons for dismissing the Appeal are not supported by the Luston Group Neighbourhood Development Plan. **DECISION:** The meeting agreed to write to the Planning Inspectorate and planning services, Herefordshire Council to state that Policy LG7 in the Luston Group NDP is intended to support the scale and type of development on the Land at the Nest, and in the opinion of the group parish council, the location of the site fits the required criteria highlighted in 5.3.14 being adjacent to the existing dispersed built form.
