**8.1** Land to the rear of Longacre, Luston. Proposed erection of two bungalows, preapplication consultation. Attended by applicant/ landowner.

**8.2** 203369 The Folly, Luston, HR6 0BX. Prior Approval for larger home extension. The extension will extend beyond the rear wall of the dwelling house by 5.68 metres. The maximum height of the enlarged part of the dwelling house is 2.95 metres and the height of the eaves of the enlarged part of the dwelling house is 2.95 metres. **8.3** 203629 The Steppes, Luston, HR6 0EA. To Crown raise - 3 Ash Trees and 2 Sycamore Trees overhaning Neighbours Property, Owners Garden Shed and Greenhouse.

**8.4** 203600 Kinley Field, Luston, HR6 0EB. Proposed works to Lawson cypresses along south eastern border of garden. Four of the eleven trees are dead/dying, likely as a result of water logging from the floods earlier this year, and/or disease. These to be dismantled completely. The remaining cypresses are showing symptoms, but at this moment are not as severely affected as the other four. Replace with four trees of a suitable species, not susceptible to water logging (e. g. alder or willow).

**8.5** 203384 Bury Vale, Luston, HR6 0EB. Proposed works to Sycamore (T1) - fell because of excessive shading to both gardens and low amenity value. Replant with a plum tree. The sycamore grew by accident and keeps re-seeding in our neighbours' lawn. In addition, the tree brings unwelcome shade to our neighbours' bungalow. They are very keen to see this tree go and for us to re- plant with the more appropriate plum.
