MINUTES OF THE MEETING OF LUSTON GROUP PARISH COUNCIL HELD AT 7.30PM ON MONDAY 5 JULY 2021 OUTSIDE CAWLEY HALL

Present: C Pearson (Vice Chairman), E Coates, A Brandish, R Bennett Jones, P Edwards, K Wood, G Poulton and W Talbot Ponsonby.

1. Receive apologies for absence – I Stevens (Chairman) and J Oatley.

2. Declarations of Interest

3. Approval of minutes from 5 May and 26 June 2021

DECISION: The minutes of the meetings were agreed and signed.

4. Ward Councillor S Bowen's Brief Report (for information only)

Ward Cllr. Bowen reported that the chief executive and leader of Herefordshire Council have been invited to Bircher Ward. The focus on drainage work has yet to lead to much activity locally which is disappointing. Hereford Hospital have reported that A&E is getting busier.

Welsh Water and Balfour Beatty are to rectify drainage issues near the school, believed to be caused by stormwater entering the foul sewerage system. The highway authority has been contacted on numerous occasions regarding the drainage problems on Eye Lane near the A49.

5. Flooding matters

The gauge board has been installed by the lengthsman at the culvert under the B4361 at Luston. The cost of installation will be covered by the Natural Flood Management (NFM) project. Balfour Beatty is to fix drainage defects by the school and on Eye Lane by Ashton. Drawings highlighting the drainage system on Eye Lane, that were kindly provided by a member of the public, have been resent to Balfour Beatty to help inform the solution. A slow running drain on the B4361 at Luston has been jetted by the highway authority. Balfour Beatty highlighted responsibilities of riparian owners at a recent online meeting. **DECISION:** Monitor the gauge board and report levels to the NFM coordinator.

6. Clerk's Report and reports on meetings attended by parish councillors

The balance of the current account on 30 June 2021 was £15,905. The two SIDs have been shipped to the manufacturer to be fitted with solar panels. A quotation will be obtained for a maintenance contract for parts not covered by the guarantee for the work. Data for the last deployment recorded an 85th percentile average speed of 32.6mph (the measure used by the Safer Roads Partnership). The annual return has been submitted to the external auditor and posted on noticeboards in the parishes as well as the website. Parish council documents have been deposited at the Herefordshire Archives, including minutes for the period 1997-2014 and old accounts. The three commons at Eyton are to be 'topped off' shortly. Highway defects have been reported, including for potholes, trees, fly-tipping and road signs.

7. Matters raised by local residents

Cllr. Wood raised a report that members of the public are concerned that hedges are encroaching on the pavement is some places in Luston. **DECISION:** A note will be included in the Eye to request that all hedge owners ensure they are properly trimmed back to allow the full width of the paths to be available.

8. Planning

8.1 211827 Willows, Broad Lane, Leominster, HR6 0AL. Proposed two storey side extension. **COMMENT:** The parish council supports the planning application.

8.2 211946 Meadow Lea, Luston, HR6 0AS. Proposed change of use from agricultural tie to 3 year temporary use as holiday let. **COMMENT:** The parish council supports the planning application. **8.3** Appeal APP/W1850/W1850/W/20/3245470 Re: 191066 Clee View Barn, Luston, HR6 0AS. Retention of mobile home. **DECISION:** It was agreed to make no further comment or representation.

8.4 Update on planning decisions. Herefordshire Council granted planning permission for 210875 Moreton Farmhouse. Works to trees are allowed for 210790 8 The Willows and 211406 13 Westland View. Prior approval is not required for 211815 Ashton Court Farm.

9. Highways and environmental matters

9.1 Road name signs and village name signs – Balfour Beatty have advised that road name signs on Tunnel Lane will 'benefit motorists'. However, the additional road name signs off the A49 at Eye Lane are not supported by the highway authority. **DECISION:** Proceed with quotation for road name signs at Tunnel Lane, Ashton and request that the decision on the requirement for additional road name signs at Eye Lane is re-considered.

9.2 Highways – Matters to bring to the attention of Balfour Beatty. **DECISION:** Potholes on the road towards Kingsland from Eyton. Overgrown hedges on Seggin Lane. Overgrown hedges along Eye Lane, and the mess left after verge cutting.

9.3 Lengthsman and P3 footpaths. **DECISION:** Reports that EX16 and EX17 are impassable will be brought to the attention of the footpath officer/ landowner. The footpaths budget for 2021-22 is £4,000 due to underspend in 2020-21.
